This area of emphasis includes programs supporting basic and urgent human needs, such as food and shelter; medical care and health; family support; education; and opportunities for at-risk youth such as leadership building and vocational and life-skills programs.

## Types of Support provided:

GLVAR may provide restricted grants to assist local charitable organizations in the operation of their programs. GLVAR may also provide the volunteer services by its Members and/or staff, access to meeting space or other in-kind support for charitable organizations.

GLVAR has partnered with Nevada Community Foundation (NCF), an independent nonprofit organization to administer and coordinate GLVAR's financial charitable donations. Community organizations receiving financial support from GLVAR must comply with NCF's guidelines and criteria.

## Grant Amount:

Donations are to be made to 501(c)(3) organizations only. Donations will generally be awarded up to \$2,500.00 each (or more if funds available).
